**DEBTORS' TWELFTH OMNIBUS OBJECTION TO THE ALLOWANCE OF
CERTAIN CLAIMS: (A) CLAIMS SUBJECT TO SUBORDINATION
PURSUANT TO SECTION 510(B), (B) EQUITY CLAIMS, (C) REDUNDANT
NOTEHOLDER CLAIMS AND (D) CONTINGENT AND/OR UNLIQUIDATED
CLAIMS**

Delta Air Lines, Inc. ("Delta") and those of its subsidiaries that are debtors and debtors in possession in these proceedings (collectively, the "Debtors"),¹ respectfully represent:

Background and Jurisdiction

1. On September 14, 2005 (the “**Petition Date**”), each Debtor commenced with this Court a voluntary case under chapter 11 of title 11 of the United States Code (the “**Bankruptcy Code**”). The Debtors are authorized to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code. The Debtors’ cases are being jointly administered.

2. On May 31, 2006, each of the Debtors filed a Statement of Financial Affairs and a Schedule of Assets and Liabilities (collectively, as may be amended from time to time, the “**Schedules**”).

3. By order dated June 5, 2006 (the “**Bar Date Order**”), the Court established August 21, 2006 as the last day by which certain proofs of claim could be timely filed in these chapter 11 cases (the “**Bar Date**”). In accordance with the Bar Date Order, written notice of the Bar Date was mailed to, among others, all creditors listed on the Schedules.

4. The Court has subject matter jurisdiction over this Objection pursuant to 28 U.S.C. § 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b)(2) and may be determined by the Bankruptcy Court. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409.

Relief Requested

5. This is the Twelfth Omnibus Objection to the Allowance of Certain Claims that have been filed by the Debtors. As part of the claims reconciliation process, the Debtors are carefully reviewing all claims and supporting documentation filed in these cases, their related books and records and the Schedules. Previous omnibus

objections have resulted in the disallowance, reduction, amendment, reclassification and/or expungement of more than \$1.1 billion in claims against the Debtors.

6. The Debtors have identified particular categories of proofs of claim that should be disallowed and expunged, reduced, deemed amended and/or reclassified, as applicable. By this Twelfth Omnibus Claims Objection and pursuant to section 502 of the Bankruptcy Code, the Debtors hereby object to, and seek the subordination, disallowance, reduction, amendment, reclassification and/or recharacterization of, the following:

- (a) each claim listed in the column “Objectionable Claims” on Exhibit A attached hereto, which the Debtors respectfully submit are, as described in greater detail below, subject to subordination pursuant to Section 510(b) of the Bankruptcy Code (collectively, the **“Claims Subject to Subordination Pursuant to Section 510(b)”**);
- (b) each claim listed in the column “Objectionable Claims” on Exhibit B-1 and B-2 attached hereto, which claims were filed by purported shareholders of the Debtors’ common stock and relate to the ownership of the Debtors’ common stock (the **“Equity Claims”**);
- (c) each claim listed in the column “Objectionable Claims” on Exhibit C attached hereto, which claims duplicate or are otherwise redundant of other claims filed by the indenture trustees for debt securities issued by or for the benefit of the Debtors pursuant to indentures (collectively, the **“Redundant Noteholder Claims”**); and

(d) each claim listed in the column “Objectionable Claims” on Exhibit D attached hereto, which claims relate to (i) litigations (including tort, employment, environmental or other similar claim) or (ii) other interests (including unvested contractual rights) for which a proof of claim has been timely filed in a liquidated amount notwithstanding that the underlying claim – by its nature – is contingent or unliquidated, and which the Debtors propose be recharacterized at the present time by the Court as “unliquidated” in amount (collectively, the “**Contingent and/or Unliquidated Claims**”; and together with the Claims Subject to Subordination Pursuant to Section 510(b), the Equity Claims and the Redundant Noteholder Claims, the “**Subject Claims**”).

7. If the relief requested herein is granted, Bankruptcy Services, LLC, as the Debtors’ authorized claims agent, will be authorized and directed to amend the claims register accordingly. In the event that any of the Subject Claims are not disallowed and expunged, reduced, deemed amended and/or reclassified, as applicable, on the grounds asserted herein, the Debtors hereby reserve their right to object to such claims on any other grounds at a later date.

Basis for Relief

A. *Claims Subject to Subordination Pursuant to Section 510(b)*

8. The Claims Subject to Subordination Pursuant to Section 510(b) include two \$100 million claims filed against Delta for alleged breaches of fiduciary duties with respect to pension plans, as well as approximately 60 claims brought by former Delta employees alleging violations by Delta of fiduciary duties under the Employee Retirement and Income Security Act of 1974 (“**ERISA**”) in respect of Delta stock held in such former Delta employees’ 401(k) accounts. The Debtors believe that, because each

of these claims assert damages arising from the purchase or sale of Delta common stock, they should be subordinated to the same priority as Delta's common stock pursuant to section 510(b) of the Bankruptcy Code.

9. Section 510(b) of the Bankruptcy Code states that:

For the purpose of distribution under this title, a claim arising from rescission of a purchase or sale of a security of the debtor or of an affiliate of the debtor, for damages arising from the purchase or sale of such a security, or for reimbursement or contribution allowed under section 502 on account of such a claim, shall be subordinated to all claims or interests that are senior to or equal the claim or interest represented by such security, except that if such security is common stock, such claim has the same priority as common stock.

Section 510(b) of the Bankruptcy Code is a remedial statute that is intended to “prevent a shareholder from converting his interest into a claim and sharing *pari passu* with other unsecured creditors.” *In re Granite Partners, L.P.*, 208 B.R. 332, 341 (Bankr. S.D.N.Y. 1997). As the Second Circuit noted in a very recent decision, section 510(b) is to be construed broadly to cover all types of direct and indirect shareholder claims. *See In re Med Diversified, Inc.*, 461 F.3d 251, 258 (2d Cir. 2006) (subordinating former employee whose claim was based on debtor’s failure to issue common stock to employee because “[the claimant’s] claim for damages is not a fixed amount but rather connected to the value of the debtor’s stock, [and] we are inclined to read section 510(b) broadly to include his claim for damages.”).²

²See also *In re Worldcom, Inc.*, No. 02-13533, 2006 WL 3782712, at *6 (Bankr. S.D.N.Y. Dec. 21, 2006) (Gonzalez, J.) (holding that “asserted rights to payment for damages related to ...unexercised stock options and to stock held in ...retirement accounts are properly subordinated pursuant to section 510(b)’); *In re Enron Corp.*, 341 B.R. 141, 151 (Bankr. S.D.N.Y. 2006) (holding that stock options that claimant/employees were required to accept as part of their annual bonus were subject to subordination pursuant to section 510(b)).

10. Moreover, as this Court and several other courts have noted, it is for Congress, not the courts, to devise exceptions to the application of section 510(b). *See In re WorldCom, Inc.*, 329 B.R. 10, 14 (Bankr. S.D.N.Y. 2005) (Hardin, J.) (“so long as the nature of the damage or harm complained of by a shareholder can be said to result as a consequence of his having purchased or sold shares of common stock or other securities of the debtor, the claimant falls within the scope of Section 510(b), and it is not up to the courts to decide that certain types of damages or harm were not contemplated by Congress or should otherwise not be included within the scope of the statute.”). Accordingly, courts have repeatedly subordinated claims brought by individual beneficiaries of 401(k) or pension funds, even when those claims were ostensibly based upon theories of breaches of fiduciary duty and violations of ERISA. *See, e.g., In re Lenco, Inc.*, 116 B.R. 141, 142 (Bankr. E.D. Mo. 1990) (holding that a claim brought by the United States Department of Labor on behalf of the bankrupt company’s employee stock ownership plan was subject to subordination pursuant to section 510(b)).

11. Here, although the Claims Subject to Subordination Pursuant to Section 510(b) come in a variety of forms (*e.g.*, claims for breach of fiduciary duties and ERISA regulations), each asserts a claim for damages arising from the purchase or sale of Delta common stock and should not benefit from an enhanced recovery as compared to other holders of Delta common stock. These Claims fit comfortably within the “broad” scope of section 510(b), as understood by the Second Circuit Court of Appeals, and several decisions within the Southern District of New York and elsewhere have concluded that 401(k) and ERISA claims are subject to subordination where the basis of the claim is that

a debtor allegedly breached some fiduciary duty or ERISA regulation in its handling of common stock. *See Worldcom*, 2006 WL 3782712, at *6; *Lenco*, 116 B.R. at 142.

12. More particularly, these claims fall within a plain reading of the literal terms of section 510(b), which subordinates any claim “for damages arising from the purchase or sale of” a security of the Debtor. Each of the Claims Subject to Subordination Pursuant to Section 510(b) asserts, *inter alia*, that the Debtors’ pension plans *should not have purchased* Delta stock or that claimants should not have been required to accept or retain Delta stock as part of their 401(k). It is difficult to conceive of a reading of section 510(b) that would *not* result in the subordination of such claims, and several other courts have arrived at the same conclusion. Holders of Claims Subject to Subordination Pursuant to Section 510(b) should not be allowed to jump ahead of other holders of Delta stock and to share in distributions made to unsecured creditors of the Debtors.

13. In addition, two of the Claims Subject to Subordination Pursuant to Section 510(b) are purported “class-action” claims filed on behalf of beneficiaries of certain of the Debtors’ pension plans. However, the Debtors are not aware of any request that has been filed with this Court or any other state or federal court requesting certification of such a class, or any order by any court granting certification. To the extent that such claims are not subordinated pursuant to section 510(b) of the Bankruptcy Code, the Debtors reserve their right to object to such claims on any other available grounds.

14. Under the Debtors’ proposed plan of reorganization, holders of Delta common stock will not be entitled to any recovery. It is unlikely that any feasible plan of

reorganization would grant a recovery to such holders. Claimants who hold Claims Subject to Subordination Pursuant to Section 510(b) should not be permitted, and under section 510(b) of the Bankruptcy Code, are not allowed, to recover more than ordinary holders of Delta common stock. Accordingly, the Debtors object to the allowance of the Claims Subject to Subordination Pursuant to Section 510(b) and request that the Court subordinate the Claims Subject to Subordination Pursuant to Section 510(b) and reclassify them as equity interests under the Plan.

B. *Equity Claims*

15. Holders of common stock of the Debtors are not owed money from the Debtors and do not have “claims” against the Debtors. *See 11 U.S.C. § 501(a)* (“An equity security holder may file a proof of *interest.*”) (emphasis added). Rather, such parties may hold “interests” in the Debtors that will be treated in accordance with the Debtors’ Joint Plan of Reorganization to the extent such parties are holders of such interests on the Voting Record Date established in accordance with the Debtors’ Motion for Entry of Order (i) Approving the Disclosure Statement; (ii) Approving Solicitation Procedures; (iii) Allowing and Estimating Certain Claims for Voting Purposes; (iv) Approving Forms of Ballots and Establishing Procedures for Voting on the Debtors’ Joint Plan of Reorganization; and (v) Scheduling a Hearing and Establishing Notice and Objection Procedures in Respect of Confirmation of the Debtors’ Joint Plan of Reorganization [Docket No. 4140].

16. As such, (i) the Equity Claims listed on Exhibit B-1, which have either been asserted in an unspecified amount or in terms of a number of shares of common stock and (ii) the Equity Claims listed on Exhibit B-2, which have been filed by purported shareholders of the Debtors’ common stock in dollar amounts based on an

alleged diminution of the market value of the common stock, should be disallowed in their entirety since they are not properly asserted as “claims” against the Debtors. The Debtors further object to these Equity Claims to the extent that the associated proofs of claim purport to seek treatment inconsistent with the treatment proposed for shareholders of the Debtors’ common stock in the Debtors’ Joint Plan of Reorganization under Chapter 11 of the Bankruptcy Code.

17. The Debtors reserve the right to object to the Equity Claims on any other grounds at any time.

C. *Redundant Noteholder Claims*

18. Claimants filing Redundant Noteholder Claims (the “**Noteholder Claimants**”) allege liability premised on certain notes and the indentures governing such notes. However, under the Bar Date Order, individual Noteholder Claimants were not required to file proofs of claim for repayment of principal, interest and other fees and expenses because the indenture trustee and agents for such notes were required to file (and in fact did file) proofs of claim on behalf of the Noteholder Claimants. To the extent that individual Noteholder Claimants have a claim, their interests are represented by their respective indenture trustee and agent. Consequently, the Noteholder Redundant Claims are duplicative and not separately allowable. Because the claims asserted by the indenture trustees and agents on the Noteholders Claimants’ behalf will survive this Twelfth Omnibus Claims Objection, the Redundant Noteholder Claims on Exhibit C should be disallowed and expunged.

D. *Contingent and/or Unliquidated Claims*

19. Each of the Contingent and/or Unliquidated Claims relates to (a) litigations (including tort, employment, environmental or other similar claim) or (b) other

interests (including unvested contractual rights) for which a proof of claim was timely filed in a liquidated amount notwithstanding that the underlying claim – by its nature – is contingent or unliquidated. The Debtors propose that the Contingent and/or Unliquidated Claims be accordingly recharacterized at the present time by the Court as being “unliquidated” in amount since they are predicated on events, circumstances or findings that have not yet occurred or may never occur. This request for recharacterization does not constitute an admission of liability by the Debtors to any of the Contingent and/or Unliquidated Claims or their related assertions and the Debtors hereby reserve their right to object to, or later litigate, such claims on any other grounds at a later date.

Responses to Objection

20. Any party wishing to oppose the relief requested herein must file a response in accordance with the Court’s Order Establishing Procedures for Claims Objections entered October 12, 2006, docket number 3381 (the “**Claims Objection Procedures Order**”), a copy of which is available at no charge on the Debtors’ Case Information Website (located at www.deltadocket.com). In the event a party does not wish to oppose the relief requested herein, it is not necessary for such party to file any response with the Court, notify the Debtors or their counsel or undertake any further action.

21. The deadline to file a response to this Objection is 4:00 p.m. (prevailing Eastern Time) on February 20, 2007.³ Consistent with the Claims Objection Procedures Order, no response shall be accepted or considered unless, prior to such deadline, it is filed with the Court, 300 Quarropas Street, White Plains, New York 10601 and actually

³ However, the response deadline for those specified “Carve-Out Parties” (as defined in the Claims Objection Procedures Order)—if any—is March 2, 2007 at 4:00 p.m. (prevailing Eastern Time).

received by (a) the attorneys for the Debtors, Davis Polk & Wardwell, 450 Lexington Avenue, New York, New York 10017, attn: Timothy E. Graulich, Esq. and (b) the attorneys for the official committee of unsecured creditors, Akin Gump Strauss Hauer & Feld LLP, 590 Madison Avenue, New York, New York 10022, attn: David H. Botter, Esq. In addition, as set forth above in the Claims Objection Procedures Order, no response shall be accepted or considered by the Court unless it includes, among other things, the following:

- (a) an appropriate caption, including the title and date of the objection to which the response is directed;
- (b) the name of the claimant, the claim number of the proof of claim (as identified on the claims register maintained on the Debtors' case information website (located at www.deltadocket.com)) and a description of the basis for the amount of the proof of claim;
- (c) a concise statement setting forth the reasons why the Court should not sustain the objection, including, but not limited to, the specific factual and legal bases upon which the claimant relies in opposing the objection;
- (d) copies of any documentation and other evidence upon which the claimant will rely in opposing the objection at a hearing;⁴
- (e) sworn declarations of persons with personal knowledge of any new facts relied upon to support the response;⁵ and

⁴ If the claimant cannot timely provide such documentation and other evidence, the claimant is required to provide a detailed explanation in the response as to why it was not possible to timely provide such documentation and other evidence.

⁵ If the claimant cannot timely provide such declarations, the claimant is required to provide a detailed explanation in the response as to why it was not possible to timely submit such declarations.

(f) the name, address, telephone number and facsimile number of a person authorized to reconcile, settle or otherwise resolve the claim on the claimant's behalf.

22. A failure by a claimant to file a response in such manner shall be deemed a waiver by such claimant of all rights to respond to such objection and consent by such claimant to the relief requested in the objection with respect to such claimant's proof of claim.

23. Pursuant to the Claims Objection Procedures Order, if a proper and timely response with respect to a given claim is not filed and served in compliance with the procedures specified therein, the Court may sustain the objection with regard to such proof of claim without further notice or a hearing.

Separate Contested Matters

24. Pursuant to the Claims Objection Procedures Order, to the extent that a response is properly and timely filed with respect to any claim to which the Debtors have objected, each such claim shall constitute a separate contested matter as contemplated by Bankruptcy Rule 9014. The filing of a response with respect to a given claim shall not delay the entry of an order sustaining the objections to each claim for which a proper response has not timely been filed and served.

Notice

25. No trustee or examiner has been appointed in these chapter 11 cases. The Debtors have served notice of this Objection consistent with the procedures set forth in the Claims Objection Procedures Order. For the convenience of the claimants, in lieu of receiving the complete Exhibits A, B-1, B-2, C and D attached hereto, each claimant listed thereon will receive a customized Exhibit including only their claims as referenced

thereon. In addition, consistent with the procedures described in the Court's Order Approving Notice, Case Management and Administrative Procedures entered October 6, 2005 (the "**Case Management Order**"), the Debtors have served notice of this Objection on (a) the Core Parties (as that term is defined in the Case Management Order) and (b) the Non-ECF Service Parties (as that term is defined in the Case Management Order).

WHEREFORE the Debtors respectfully request the disallowance and expungement, reduction and allowance, and/or reclassification, as applicable, of the claims listed on Exhibits A, B-1, B-2, C and D attached hereto, and such other and further relief as is deemed just and proper.
